Pursuant to Chapter 78, Walled Lake City Code, as amended, same being the Uniform Traffic Code for Cities, Townships and Villages of Michigan, as amended, and in the interest of Public Safety and convenience, the following Traffic Control Order is hereby issued by Paul J. Shakinas, duly authorized as Traffic Engineer for the City of Walled Lake.

Issuance of this Traffic Control Order was preceded by study and investigation of traffic conditions on the following public road or roads in the City of Walled Lake, Michigan:

- **CLOSE EAST WALLED LAKE DRIVE FROM N. PONTIAC TRAIL TO LEON.  
FROM 9:00 am – 1:00 pm. (Two class 3 barricades at Leon / One Class 3 at Pontiac Trail)**
- **CLOSE MARKET STREET AT N. PONTIAC TRAIL  
FROM 9:00 am TO 1:00 pm. (Two class 3 barricades)**
- **CLOSE LIBERTY STREET/NORTHPORT STREET AT N. PONTIAC TRAIL  
FROM 9:00 am TO 1:00 pm. (Four class 3 barricades)**
- **CLOSE NICOLET (EAST & WEST) STREET AT N. PONTIAC TRAIL  
FROM 10:45 am TO 1:00 pm.**
- **CLOSE S. COMMERCE ROAD AT N. PONTIAC TRAIL  
FROM 10:45 am TO 1:00 pm**
- **CLOSE COMMON STREET (NORTH & SOUTH) AT N. PONTIAC TRAIL  
FROM 10:45 am TO 1:00 pm.**
- **CLOSE NORTHBOUND N. PONTIAC TRAIL AT E. WALLED LAKE DRIVE  
FROM 10:45 am TO 1:00 pm.**
- **CLOSE SOUTHBOUND N. PONTIAC TRAIL AT W. WEST MAPLE  
FROM 10:45 am TO 1:00 pm.**
- **CLOSE EASTBOUND W. WEST MAPLE AT N. PONTIAC TRAIL  
FROM 10:45 am TO 1:00 pm.**
- **CLOSE WESTBOUND E. WEST MAPLE AT DECKER (WEST OF DECKER)  
FROM 10:45 am TO 1:00 pm. (One class 3 barricade)**
- **CLOSE WOODS CT. AT E. WEST MAPLE  
FROM 10:45 am TO 1:00 pm. (One class 3 barricade)**

- **CLOSE EASTBOUND N. PONTIAC TRAIL AT S. COMMERCE (EAST OF S. COMM.) FROM 10:45 am TO 1:00 pm. (One class 3 barricade)**

After said investigation, it is hereby ordered and directed that the Department of Public Works erect barricades at the above listed locations no later than possible.  
Signs in accordance with the Michigan Manual of Uniform Traffic Control Devices as required by the Walled Lake City Code, said signs to give notice of the following determination:

**ERECT TWO CLASS 3 BARRICADES AT LEON STREET AND EAST WALLED LAKE DR.**

**ERECT TWO CLASS 3 BARRICADES AT MARKET STREET AND N. PONTIAC TRAIL.**

**ERECT TWO CLASS 3 BARRICADES AT LIBERTY STREET AND N. PONTIAC TRAIL.**

**ERECT TWO CLASS 3 BARRICADES AT NORTHPORT AND N. PONTIAC TRAIL.**

**ERECT ONE CLASS 3 BARRICADE AT EAST WALLED LAKE DR. AND PONTIAC TR.**


**ERECT ONE CLASS 3 BARRICADE AT WOODS CT. AND E. WEST MAPLE.**

**ERECT ONE CLASS 3 BARRICADE AT DECKER ROAD AND E. WEST MAPLE.**

**ERECT ONE CLASS 3 BARRICADE AT S. COMMERCE AND N. PONTIAC TRAIL.**

**PLACE TWO LARGE BARRELS AT EACH ENTRANCE TO MAPLE PLAZA (8 BARRELS).**

**PLACE TWO LARGE BARRELS AT THE ENTRANCE TO TIM HORTON'S/WENDY'S.**
