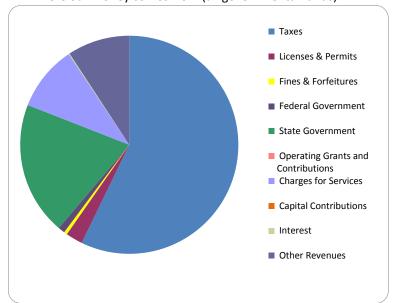
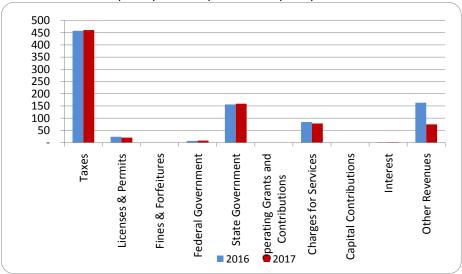

1. Where our money comes from (all governmental funds)



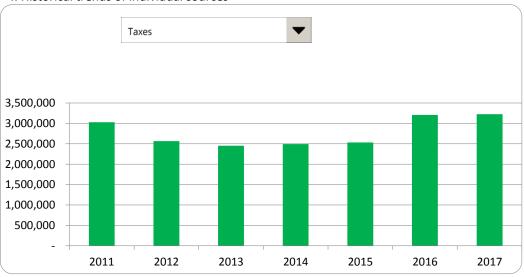
3. Revenue sources per capita - compared to the prior year

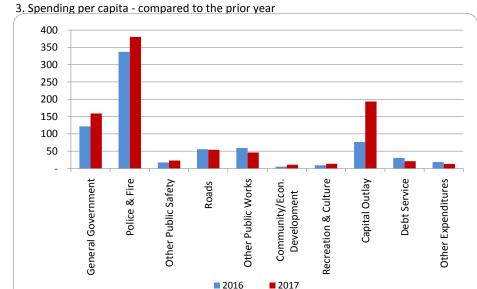

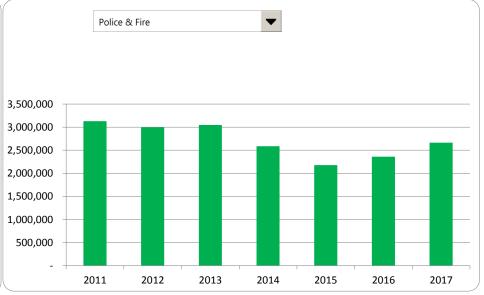

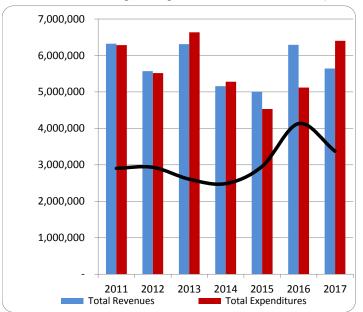

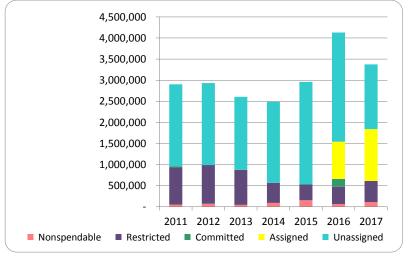

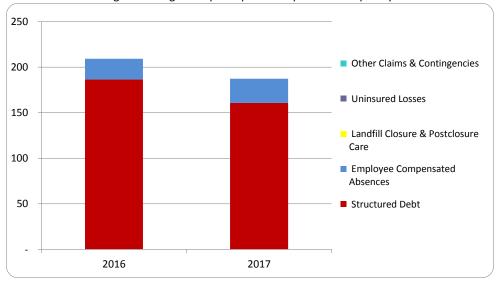
