AUDIENCE PARTICIPATION:

Mindy Fernandes, 45400 W. Pontiac Trail – she is the new staff legislative director for State Representative Kathy Crawford and offered any assistance to the administration of Walled Lake in achieving their goals for the city.

Evan Riskin, 120 Leeds and Keith Wagner, 127 Leeds – said it has come to their attention the owners of the property in Novi that is leasing the organization that is running Driftwood were turned down for a commercial dock in Novi. Mr. Riskin said the owner who is leasing the property also owns the land on the Walled Lake side of the beach, which is residential and has leased the property to the organization for a dock for the commercial restaurant. Mr. Riskin explained; the residents are opposed to this site being used as commercial dock in Walled Lake for Driftwood in Novi. Mr. Riskin said this will create an unnecessary pedestrian traffic hazard.

City Manager Whitt explained that the administration will look into the issue.

COUNCIL REPORT:

Mayor Pro Tem Owsinek explained the Great Lake to Lakes Trail is coming along nicely, however the interlocal agreement is still being worked on.

Council Member Ambrose explained a few items that were discussed at the last DDA meeting including the budget amendment for the Decker Road, sidewalks, etc. Mr. Ambrose said there were several DDA boards members that have taken exception to Council Member Costanzo's comments. Mr. Ambrose said Mr. Costanzo attended the last DDA meeting. Mr. Ambrose said the DDA board members issues, were regarding comments made on Facebook and other social media entities. Council Member. Ambrose explained that there was a breakdown of the proposed funding of the Decker Road match by the DDA and that sheet was distributed at that time. Council Member Ambrose explained that he provided Council Member Costanzo a copy of the financial breakdown. Council Member Ambrose opined that for Mr. Costanzo to give the impression that he was not aware of the costs cause members of the DDA to take exception. Council Member Ambrose explained to Council Member Costanzo that he should attend DDA meetings and ask questions at the DDA meeting, and not make remarks at the City Council meetings as if DDA issues had never been discussed before.

Council Member Costanzo questioned staff on page 45 of the check disbursement report what the \$5,971 buyout of Toshiba was.

City Manager Whitt said this is not the time for people to perform and hold a gotcha moment.

Council Member Costanzo said rise to a point of order as the remarks were a personal affront to a council member. Council Member Costanzo asked the chair whether the point of order is taken or not.

Mayor Ackley disposed of the point of order by ruling there was no breach of the assembly rules by the prior speaker and corrected Council Member Costanzo by reminding him that it was the council member who had promised that if he had questions he would bring those question to the attention of staff before the council meetings. Mayor Ackley explained to Council Member Costanzo that the City Manager would gladly sit down with him at any point and answer questions.

City Manager Whitt explained to Council Member Costanzo the expenditure was for a buyback when the city went to a new company, it was a wash, \$5,000 out and \$5,000 back. Manager Whitt explained to Council Member Costanzo that a phone call could have answered this question. Mr. Whitt said the city changed copy machine companies because there was a superior deal. Mr. Whitt explained that nothing sinister occurred with this transaction and opined that Council Member Costanzo wanted to perform.

Council Member Costanzo said he rises to a point of order; this is a personal affront against him.

City Manager Whitt suggested council take a vote if these actions were a personal affront to Council Member Costanzo.

Mayor Ackley disposed of the point of order by ruling there was no breach of the assembly rules by the prior speaker and calling for a roll call vote on the pending motion.

Mayor Ackley explained she received an email from Ms. Amy Aubry from Oakland County in regards to the City's application for grant monies for road improvements.

City Manager Whitt explained the notice was that the city grant application was approved and will receive a match from the County and will go before the County Commissioners for approval at their next meeting.

Assistant City Manager Pesta explained this is a new program through the County and it is in its fourth year of operation. Mrs. Pesta explained the purpose is for economic development by matching limited funds specifically targeted for maintenance on the roadways and or improvement projects on the roadways. Mrs. Pesta explained the city submitted the project this year with a total project cost of \$32,000 and the County will match up to half. Mrs. Pesta said the County match for this year is \$13,138. Mrs. Pesta said the plans are to address the entrance of N. Eddie Street and an exposed culvert, fix manhole covers off Market Street and Chestnut Ridge.

City Manager Whitt explained he met with DDA Chairman Ambrose about the city's continued road program and he had also met with staff representatives of the Road Commission of Oakland County. Mr. Whitt said there will be road work along Pontiac Trail from Welch to S. Commerce. City Manager Whitt explained County Commissioner Long was in attendance at the Road Commission staff meeting and it is clear Commissioner Long is working for Walled Lake.

CORRESPONDENCE

Mayor Pro Tem Owsinek requested Clerk Stuart to read three letters of correspondence into the record.

Dear Mayor and Council Members:

This letter is to register a formal complaint about the misconduct of City Council Member Gabriel Costanzo. I am calling for a formal investigation into the actions of Council Member Costanzo using the badge and indicia of his office of City

Council Member to demonize, vilify and defame members of our business community and other officials by use of social media platforms.

I am proud of the City of Walled Lake and the direction it has taken in recent years and want to continue as a long-term property and business owner in our fine community. The continued misrepresentations about the conduct of our Downtown Development Authority (DDA) board members by Council Member Costanzo is unwarranted, unprofessional and is doing irreparable harm to the business interests of our community. Given the facts available in the public record it seems apparent that the actions of Costanzo are ethics violations.

As many of you know, I am the newest member of the DDA. I have been on this board for less than eight months and do not understand motives for the kind of dirty politics used by Costanzo and his political partners. Although I may be the newest member of the DDA, I want each of you to know that I am one of the longest standing tax-paying business owner and resident in Walled Lake. Erin Industries has been doing business in the city since 1974, and I was born in the City of Walled Lake in 1961. So, in one aspect or another, I have paid taxes to Walled Lake for over fifty-eight years.

I found it to be a compliment to be nominated by the Mayor to the DDA board and to be approved by the City Council for board membership. I felt that it was an invitation to be involved in growing new and existing businesses in our community.

I am a university graduate and the other DDA board members with whom I serve are high-level professionals with college educations. Indeed, of the DDA board Members with whom I serve; one is a lawyer, one is a certified public accountant, another is a license general contractor and developer and there are other board members who are university graduates who are prominent business owners and one even serves as an assistant to a Michigan State Representative. This group of highly educated individuals have a sound understanding of the Michigan DDA law, the rules and guidelines set out by the State, County and City of Walled Lake. We as DDA board members make sound, rational decisions within those parameters.

It would never have occurred to me that a Walled Lake City Council Member and his cohorts would use social media platforms to purposely misguide City residents regarding the official actions of the volunteer DDA board members. It is unclear to me why the personal attacks are occurring, but he is damaging this community.

Council Member Costanzo stated at the council meeting that he had read the DOD law and that the DDA board's decision to match the grant to fix Decker Road (a gateway to downtown) was outside the scope of DDA authority yet he suggested that the DDA could spend money in places that is clearly outside the

authority of the statute. Council Member Costanzo also made a patently untrue statement that the State of Michigan funds the DDA and another untrue statement that he was not given information about the DDA budget amendment that provided DDA funding to match the grant to fix Decker Road.

These untrue statements, and the unqualified legal opinion begs the questions about Council Member Costanzo's motives, his employment and business experiences, his educational background, and overall his credentials. I want those questions answered.

While the DDA has no legal authority or ability to fix any city subdivision, it can do a lot to help the community at large as was the example of our actions to provide matching funds for the Decker Road gateway. According to the rules and guidelines we must follow, we may only direct funds for business development which, in the long run helps to fix the community at large and strengthens the business community.

Council Member Costanzo's reckless disregard for truth continues to damage the Walled Lake business community and the city as a whole. I call on this City Council to take appropriate action.

It's bad enough for the image of our businesses and our community that certain people who are political associates of council member Costanzo are falsely reporting and making libelous posts on social media but it's even worse when these efforts are fostered by our own elected public official.

I love this city and have seen it grow exponentially over the last 45 years. The improvements made in recent years have been huge. These recent improvements are things we can all be proud of. For a sitting council member to continuously fuel dissention in our city is counterproductive for everyone.

I ask that this council consider the options for correcting the problems created by this Council Member's inappropriate use of his public office.

COUNCIL COMMENTS:

Council Member Robertson invited everyone to the city's Memorial Day Parade.

Council Member Costanzo said he would like to address the comments regarding our Decker Road project stating he believes it is a direct correlation to the omissions in the minutes.

Council Member Costanzo stated that at the last council meeting, he specifically brought up that the DDA had opined that they could do work outside of the DDA boundaries but there was no breakdown of the remaining \$307,000. Council Member Costanzo said that nothing was presented to council; nothing was presented to him at the DDA meeting; nothing was presented explaining where that money was going to be spent.

Council Member Costanzo stated he made the request per the City Charter stating he wanted to know where every dollar was being spent. Council Member Costanzo stated that the vote by the city council on the budget amendment was "irresponsible". Council Member Costanzo further

stated that, "Nobody had read that document other than a member to the DDA. I stand behind that."

Council Member Costanzo stated, "I opposed the two employee contracts which I thought were fiscally irresponsible and I advocated our duties as council members I thought it was irresponsible and I stand by that and I believe what is going on here is retaliation in part because of my opposition to the DDA funding as well as my opposition to the employee agreements that I thought were excessive with the fringe benefits, their rates, their salaries and such'.

Council Member Costanzo stated, "When I discussed about the contracts at last meeting, I asked the city attorney if I would be violating any ethics or laws if I were to discuss the contracts. The contracts were a matter of public record. I am allowed."

Council Member Costanzo stated, "I will not submit my questions in advance where the monies are going, that is why we get the council packet. I stand behind that and I'll stand behind everything I say. So, the three members of the DDA oppose, write letters, I stand by my actions.

Council Member Costanzo stated, "You can read every one of my posts and there is not one criticism of the DDA. I stand behind that and I will continue to do that. This resolution; do what you want I will fight but I stand behind my actions and my words'.

Council Member Ambrose opined Council Member's Costanzo short memory, stating that Council Member Costanzo sat at the DDA meeting, heard the discussion with an attorney present. Council Member Ambrose stated that the DDA board membership is comprised of an attorney, a professional CPA, and board members with bachelors' and masters' degrees. Council Member Ambrose opined that these members have been on the DDA longer and have fought more fights than Mr. Costanzo has had time in the city.

Council Member Ambrose explained to Council Member Costanzo that he heard the discussion as the DDA meeting, he asked no questions, he heard the numbers, he still asked no questions. Council Member Ambrose stated, Council Member Costanzo sat there speechless and motionless. Council Member Ambrose stated the DDA board members went through all their discussions and voted unanimously for the budget amendment and forward it to council.

Council Member Ambrose opined that Council Member Costanzo gets to the council and he acts as if he never heard the discussions, stating, "This is very disingenuous to the people. The numbers were available at the DDA meeting, they were all discussed with what the costs were the five different categories and what the money was going to be spent on."

Council Member Ambrose explained that the budget amendment was sent to the council for their final approval and Council Member Costanzo asked questions as if he never saw the numbers.

Council Member Ambrose stated that he gave Council Member Costanzo the actual breakdown from the Finance Director and gave the paperwork to Council Member Costanzo with the numbers being entered into the motion.

Council Member Ambrose explained that the DDA stands for Downtown Development Authority, the DDA exists for enhancements and improvements to the downtown; Decker Road is in the gateway to the downtown. Council Member Ambrose explained that the DDA cannot spend money on subdivisions or into residential areas not connected to the downtown.

Council Member Ambrose stated the council is helping and getting work done, there are no special tax assessments, the water lines will be done, and if there is anything further the people want done it will be discussed. There are no special assessments.

Council Member Ambrose reminded everybody of the Memorial Day parade and there will be a special guest joining us.

Mayor Ackley said this will be another great parade, one of the city's local businesspeople have requested, Rup Raj from Channel 2 news join the council in the parade and allow Channel 2 coverage on this great parade.

Mayor Pro Tem Owsinek asked City Manager Whitt how brief the minutes could be.

City Manager Whitt explained the law requires that council actions be included in the minutes, but it does not require names of donors be included. The City Clerk makes the decisions and if council votes to add something the clerk left out then it can be added. Manager Whitt explained that the City Council adopted Roberts Rules of Order and motions to amend may be made, but motions that have no support fail and are not required to be in the minutes. City Manager Whitt explained that the Trail Council staff, prepares bare bone minute packets, they included only the motions. Manager Whitt stated that the Trail Council does leave out at times, significant events. Mr. Whitt explained as an example, that he was in attendance at a Trailway meeting where a donor that Council Member Costanzo requested to have his name in the minutes, spoke and called this Council blackmailers and extortionists. City Manager Whitt explained he walked out of the Trailway Council meeting because of that bad behavior, but those remarks and that action was not recorded in the Trailway Council minutes. City Manager Whitt stated the donor accused the Walled Lake City Council of crimes. This is the same individual that Council Member Costanzo requested to be in the city's minutes. City Manager Whitt explained that Council Member Costanzo was present at the Trailway Council meeting when this occurred, but Council Member Costanzo did not call for that to be placed in the Trailway Council minutes. City Manager Whitt opined that he felt the minutes are fine the way they were present by the City Clerk.

MAYOR'S REPORT:

Mayor Ackley said the public deserves to have a general outline of what happens and everyone is entitled to an opinion, but when you have board members like the DDA who serve for no money, they are volunteers, two are here tonight, Mr. Atwell and Ms. Fernandes, when accusations are placed on social media of wrongdoing, misappropriations of DDA funds, it becomes very serious. Mayor Ackley said she does not like to see any volunteer spoken about in this manner.
