1. Case2021-05Applicant:Jonathan BoboigeLocation:222 S. Pontiac TrailRequest:Non-use Variance

This matter relates to property at above referenced location. Applicant proposes to construct roof over front porch. Except as expressly provided by this article, the minimum front setback in single family districts shall be based on the established residential building pattern (ERBP), or the minimum setback specified in the schedule of regulations (section 51-17.01), whichever is less. The ERBP setback shall be equal to the average of the front setbacks of the immediately adjacent dwelling on each side of the subject parcel on the same side of the road and in the same zoning district as the subject parcel, subject to the following requirements:

A. In the event that one of the adjacent parcels is vacant, then the minimum setback specified in section 51-17.01 shall be used for that parcel in calculating the ERBP.

B. In the event that the subject parcel is on a corner, then the minimum setback specified in section 51-17.01 shall be used in the ERBP calculations as the adjacent setback figure for the side of the parcel that adjoins a street.

C. The front setback of each adjacent structure shall be measured at the shortest distance between the structure's exterior surface and the front lot line.

This matter relates to property at above referenced location. Applicant proposes increasing impervious surface to 39.7%. Applicant exceeds Article 51-17.02(M) Impervious surface in single-family districts. A maximum of 35% of the parcel shall be covered by impervious surfaces in the R-1A and R-1B districts.

Members of the public participating during the meeting via ZOOM will wait in a virtual queue until called upon during the appropriate participation period. Because of limitations on un-muting and re-muting members of the public, there will be only one period per case.

When audience participation is permitted, members of the public will be called one at a time, as would happen during an in-person meeting.
