#### 2. 2012 Local Road Improvements

Coordinator McGill informed City Council that there is \$94,000 remaining in the road bond account for the project in 2010 and this must be spent by June 30, 2011. In order to save on time, they would like to extend the contract with Nagle Paving to complete work on Wanda, Wabasso and Wellsboro. This will use the \$94,000 in road bonds and will require \$39,000 from the Local Road Construction line item. There is \$82,000 budgeted in that account currently.

Mayor Roberts reported on the Downtown Development Authority meeting held on May 8, 2012.

She also noted that the Road Commission for Oakland County informed her that the specifications for the concrete used on North Pontiac Trail was submitted to the Federal agency and it met their standards so they see no reason to conduct further testing. They assured her that they do not want these issues again in the future.

Coordinator McGill also updated Council on the Oakland County Parcel Exchange. Oakland County submitted a site plan for the fiber optic hub to be located in Riley Park. It is just for Council's information at this point.

#### 1. Wixom Lodging Agreement

City Attorney Vanerian explained that this is an agreement for the City of Walled Lake Police Department to lodge their prisoners in the Wixom holding facilities. This also requires us to list them as an additional insured on our insurance policy.

Police Chief Shakinas added that we average 8-12 people a month and use our facilities during the day while the staff is here. The biggest change is that the administration of the contract should be handled between the City Managers and not the Police Chiefs. Fees are the same.
