Pursuant to Chapter 78, Walled Lake City Code, as amended, same being the Uniform Traffic Code for Cities, Townships and Villages of Michigan, as amended, and in the interest of Public Safety and convenience, the following Traffic Control Order is hereby issued by Paul J. Shakinas, duly authorized as Traffic Engineer for the City of Walled Lake.

Issuance of this Traffic Control Order was preceded by study and investigation of traffic conditions on the following public road or roads in the City of Walled Lake, Michigan:

- **CLOSE EASTBOUND W. WEST MAPLE AT LADD  
FROM 09:30 am TO 1:00 pm. (One class 3 barricades)**
- **CLOSE EASTBOUND E. WEST MAPLE AFTER PARADE PASSES PONTIAC TRAIL  
(One trailer of Archer Barricades)**
- **CLOSE COMMON STREET (NORTH) AT N. PONTIAC TRAIL  
FROM 10:45 am TO 1:00 pm. (Three barrels)**
- **CLOSE NORTHBOUND N. PONTIAC TRAIL AT E. WALLED LAKE DRIVE  
FROM 10:45 am TO 1:00 pm. (One class 3 barricade)**
- **CLOSE SOUTHBOUND N. PONTIAC TRAIL AT W. WEST MAPLE  
FROM 10:45 am TO 1:00 pm.**
- **CLOSE NORTHBOUND N. PONTIAC TRAIL AT W. WEST MAPLE  
FROM 10:45 am TO 1:00 pm.**
- **CLOSE E. WEST MAPLE AT DECKER (WEST OF DECKER)  
FROM 10:45 am TO 1:00 pm. (Two class 3 barricades, and 1 trailer of Archer Barricades)**
- **CLOSE WOODS CT. AT E. WEST MAPLE  
FROM 10:45 am TO 1:00 pm. (One class 3 barricade)**
- **CLOSE SOUTHBOUND N. PONTIAC TRAIL AT S. COMMERCE (WEST OF S.  
COMM.)  
FROM 10:45 am TO 1:00 pm. (One class 3 barricade) (Two barrels for Lafontaine  
driveway off Pontiac Trail)**
- **CLOSE GAMMA AT MAPLE  
FROM 10:45 am TO 1:00 pm. (Three barrels)**

After said investigation, it is hereby ordered and directed that the Department of Public Works erect

barricades at the above listed locations no later than possible.  
Signs in accordance with the Michigan Manual of Uniform Traffic Control Devices as required by the Walled Lake City Code, said signs to give notice of the following determination:

**POST DETOUR SIGNS AT PONTIAC TRAIL AND WALLED LAKE DRIVE.**

**PLACE FOUR LARGE BARRELS AT LIBERTY STREET AND NORTHPORT ON N. PONTIAC TRAIL.**

**PLACE THREE LARGE BARRELS AT PONTIAC TRAIL AND NICOLET.**

**ERECT ONE CLASS 3 BARRICADE AT PONTIAC TRAIL AND EAST WALLED LAKE DR.**

**ERECT TWO CLASS 3 BARRICADES AT DECKER ROAD AND E. WEST MAPLE.**

**(SANDBAGS) (THREE BARRELS FOR D&M DRIVES ON MAPLE& DECKER).**

**ERECT ONE CLASS 3 BARRICADE AT S. COMMERCE AND N. PONTIAC TRAIL.**

**(SANDBAGS) (TWO BARRELS FOR LAFONTAINE DRIVE ON PONTIAC TRAIL).**

**ERECT ONE CLASS 3 BARRICADES AT W. WEST MAPLE AND LADD RD.**

**PLACE THREE LARGE BARRELS AT THE EXIT OF THE PARADE ROUTE ON E. WEST MAPLE.**

**PLACE THREE LARGE BARRELS AT THE ENTRANCE TO TUFFY'S ON PONTIAC TRAIL.**

**PLACE THREE LARGE BARRELS AT THE ENTRANCE TO TUFFY'S ON E. WEST MAPLE**

**PLACE TWO LARGE BARRELS AT EACH ENTRANCE TO MAPLE PLAZA (8 BARRELS).**

**PLACE THREE LARGE BARRELS AT THE ENTRANCE TO TIM HORTON'S/WENDY'S.**

**PLACE THREE LARGE BARRELS AT THE ENTRANCE TO SUNOCO ON E. WEST MAPLE**
