- Alterations and repair work determined by the electrical official to be of a minor nature.
- When an electrical system rating does not exceed 400 amps.
- Work completed by a governmental subdivision or state agency costing less than \$15,000.00.

5. Applicant Signature

A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after commencing the work. **A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION.
